## ACKNOWLEDGEMENT, ACCEPTANCE AND RELEASE

The undersigned hereby acknowledges and agrees that In order to create a positive experience at the White Mountain Community Garden ("WMCG" or "Garden"), anyone who enters the Garden or participates in any WMCG activity, for any reason, does so solely at each's own risk, and agrees (1) to work in harmony, (2) to abide by the Garden Rules, and (3) that any photos or visual media that may be taken by WMCG at the Garden or during any WMCG activity may be used by WMCG for any lawful purpose and that WMCG has no liability for damage or loss of personal property or personal injury.

In consideration of being permitted to participate in any way in the Garden or any WMCG activity, the undersigned does hereby, on behalf of myself, my minor children, my and my minor children's personal representatives, executors, administrators, heirs, guardians, next of kin, successors and assigns, and any guests or invitees I bring into the garden (herein referred to as "Releasers") do hereby waive, release, discharge and covenant not to sue WMCG, its elected and appointed officials, employees, volunteers, sponsors and agents, including others who give recommendations, directions, or instructions as part of WMCG and any activities conducted by WMCG, for any and all loss or damage and any claim or demands therefor on account of injury to any person or property arising out of or related to use or occupancy of WMCG, including any volunteer service by me, or any of my minor children, guests or invitees.

Except for any volunteer services performed by me at WMCG, I agree to indemnify and save and hold harmless WMCG from any loss, liability, damage or cost that WMCG may incur arising out of or related to my, or my minor children's or my guest's or invitee's use or occupancy of WMCG.

Releasers further agree that, without restriction, photos or other visual media, whether of adults or children, that may be taken at the Garden or at any WMCG activity may be used by WMCG for any lawful purpose, including use in magazine articles, brochures, and other publications and promotional materials, whether electronic or otherwise, and further waive any right to inspect or approve the finished product and waive any right to royalties or other compensation, if any, arising from or related thereto.
